

# Domestic and international parcel deliveries from contract customers

## Services and supplements

The PostNord Parcel service is for B2B consignments.

MyPack is a B2C service for recipients in Denmark and abroad. There are two options:

- MyPack Home, where the consignment is delivered to the recipient's home address, and
- MyPack Collect, where the recipient picks up the parcel from an agreed delivery point.

Parcel prices are set on the basis of a shipping profile. The prices are stated in an appendix to the Customer Agreement.
