For letters larger than C4 (33x23 cm) and/or more than 3 cm thick, pr item 9.00

* Direct Mail can only be sent to recipients in Denmark and must be franked by PP (Postage Paid) impression. Direct Mail must be handed over for carriage at a letter sorting centre, but can also be dropped off at selected business drop-off locations against payment of a surcharge.

3) The price structure is based on a step model where the price per item within the individual step is applicable to the items within this step only.

9) For maxi letters the minimum amount of 1,000 pieces applies for all weight intervals across. In case of payment up to the minimum, the residue will be calculated from the price in the highest weight interval in the batch.
