

# Domestic and international parcel deliveries from contract customers

## Services and supplements

PostNord Parcel can be sent from business senders to business recipients.

MyPack can be sent from business senders to private recipients in Denmark and abroad, and here are two options:

- MyPack Home, which is delivered to the recipient's home address, or
- MyPack Collect, which is the recipient picks up from an optional service point.

Parcel prices are set on the basis of a shipping profile. The prices are stated in an appendix to the Customer Agreement.
