Signature Assurance (Denmark, Sweden, Norway and Finland)	PostNord Home	If it is important that the parcel is delivered to the recipient with a signature, you must select the "Signature Assurance" service. We ensure that the parcel is not left at the address or placed in the recipient's mailbox. The recipient can, via FlexChange, move the parcel for collection at a parcel shop or parcel locker in the Nordics. When sending LQ, you must add this service to the parcel and provide the UN number, substance name, and quantity (net weight). When sending LQ parcels to Finland, Åland Islands, Estonia, Latvia, and Lithuania, you must also provide the proper shipping name. For N.O.S. goods: technical names and category/classification. Batteries falling under exception SP188 (max. 20/100 Wh lithium) are exempt and must not be sent with this service, but simply labeled with the battery mark (UN number). At postnord.dk you can find the list of permitted UN numbers. Only one substance (UN number) per parcel is allowed.	+0.00
FlexDelivery (Denmark)	PostNord Home PostNord Parcel	If you send parcels to recipients who are not home at delivery, you can choose the "FlexDelivery" service. This saves the recipient a trip to the parcel shop and reduces the number of uncollected parcels returned. You simply specify where the parcel may be placed, e.g., in the carport or in front of the door and PostNord will deliver it there.
